§§ 1-7) is a United States antitrust law passed by Congress under the presidency of Benjamin Harrison, which regulates competition among enterprises. The Sherman Act broadly prohibits (1) anticompetitive agreements and (2) unilateral conduct that monopolizes or attempts to monopolize the relevant market.

Sherman "Restraint of Trade" Section 1. -every contract combination in the form of trust in restraint of trade or commerce among the several states, is declared to be illegal. -restraint trade definition: is any agreement between two parties that substantially reduces competition in the marketplace.
